Complex litigation requires two interacting spheres of activity:

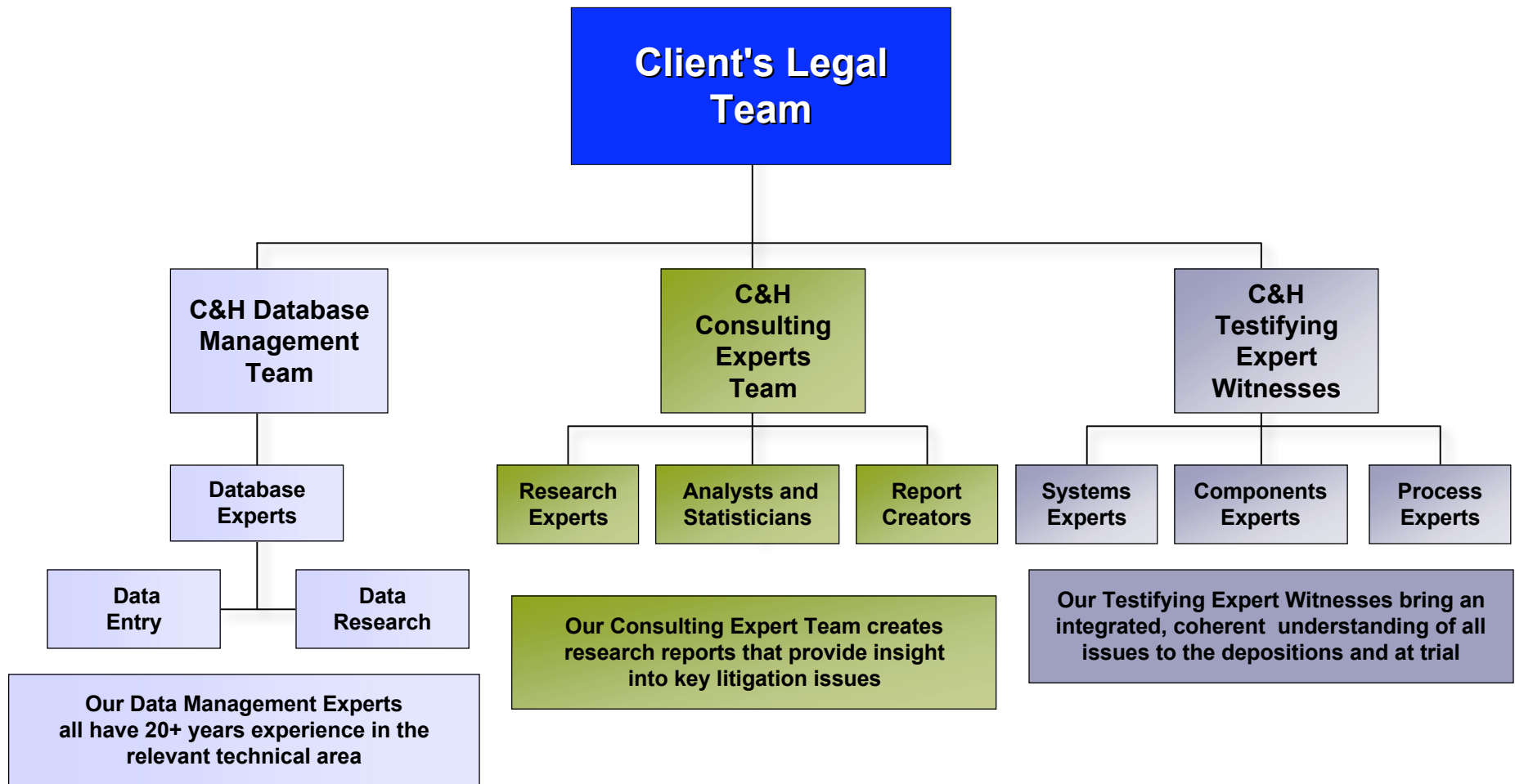
- **Legal work of the litigating attorneys and the paralegal team**

Space News Reports



- **A U.S. District Court in California has dismissed satellite builder Astrium's lawsuit alleging fraud by a group of subcontractors including the former TRW Inc., saying recent changes in California law prevent it from considering such cases.**
- **Astrium officials reacted with surprise to the ruling and said they would appeal it to the 9th U.S. Circuit Court of Appeals, a federal court. "This story is not over," Astrium spokesman Remi Roland said. "The decision was not made on the merits of our case."**
- **TRW — now a unit of Northrop Grumman Corp., Corning Netoptix and Optical Filter were the defendants in the lawsuit. The companies were subcontractors on solar arrays aboard telecommunications satellites built by Astrium of Europe.**
- **Astrium's lawsuit alleges that the subcontractors were responsible for, and had knowledge of, a defect that caused the solar panels on certain Astrium satellites to darken in orbit, reducing their power-generating capacity.**
- **An expensive consequence of the defect was the decision by New Skies Satellites NV of The Hague, Netherlands, to cancel its contract for the KTV/NSS-6 satellite following delivery delays.**
- **Astrium was late in completing the spacecraft because it had to check the status of the solar arrays. That contract cancellation alone cost Astrium \$97 million.**
